In the second instance:

They satisfy any one or more of the **First Instance Area** criteria (1) to (5) above but in respect of any other **Parish** in Stratford-on-Avon District.

In the third instance:

They satisfy any one or more of the **First Instance Area** criteria above but in respect of an area (if any) (a "**Third Instance Area**") which comprises that of any one or more named local planning authorities such as may from time-to-time be designated or notified by the **Head of Service** as a relevant strategic housing market area or area of similar description in accordance with and by reference to any agreement entered into by the District Council pursuant to the discharge of its duty (the duty to co-operate) under section 33A of the Planning and Compulsory Purchase Act 2004 (as inserted by section 110 of the Localism Act 2010) or any equivalent subsequent enactment.

In the fourth and final instance:

They satisfy any one or more of the **First Instance Area** criteria above but in respect of any other area within England outside the **First to Third Instance Areas** specified above.

and have done so for at least the past 12 months for an average of not less than 16 hours per week;

(5) Currently has a close family member (mother, father, brother, sister, son, daughter, nephew, niece, grandparent, grandson, granddaughter or such other relatives as the District Council agree qualify in the particular circumstances of any given case as a close family member
